This Information is provided, pursuant to article 13 of the European Regulation on the protection of persons and Personal Data n. 679/2016 (hereinafter also "GDPR"), in relation to the Personal Data of which the University of Rome "Foro Italico" (hereinafter also "University" and / or "Controller"), will come into possession as a result of the purposes listed below.
